Dear Mr. Wade:

Thank you for the opportunity to provide comments in regard to the February 9, 2010 proposal by the Army Corps of Engineers (Corps) to revise its policy regarding regional variances from the national standards for vegetation management on levees that are part of the Public Law (PL) 84-99 program. We are writing to you on behalf of the King County Flood Control Zone District Advisory Committee, a 15-member group of elected officials established in 2007 under Washington state law and King County code to provide guidance on flood risk reduction policies and priorities to the King County Flood District Board of Supervisors. The Advisory Committee includes representatives from the following local entities:

- Maple Valley Unincorporated Areas Council (representing six Unincorporated Area Councils in King County)

We respectfully express our dissatisfaction with the Corps' proposed revisions. The Advisory Committee is strongly invested in ensuring that limited public funds are spent effectively and efficiently to reduce flood risks and implemented consistent with local, state, and federal environmental requirements such as the federal Clean Water and Endangered Species Acts. Local governments in the Puget Sound region continue to be caught between conflicting federal mandates: we are required to degrade riparian areas identified as critical habitat for federally

listed species so that we can retain our eligibility for federal PL 84-99 funding for critical public safety projects. In other words, to comply with one federal mandate we must violate another. We simply cannot afford these conflicting mandates, these conflicting public messages, and this ongoing inefficient expenditure of limited public dollars. Nor can we afford the federal ESA legal liability that is effectively passed on to local governments by the continued lack of consultation and coordination between federal agencies.

The King County Flood Control District Advisory Committee requests that:

- The Corps consult with the National Marine Fisheries Service (NMFS) and the United States Fisheries and Wildlife Service (USFWS) regarding the impacts of the Corps' levee vegetation requirements on species listed under the federal ESA. We note that in a 2003 letter to the Corps, NMFS found that Corps levee vegetation maintenance program was "likely to adversely affect" listed fish species, and we encourage to Corps to re-initiate this consultation.
- The Corps withdraw the current proposal and base any future policy changes regarding vegetation management on scientific research, which the Corps committed to at the Corps-sponsored symposium, "An Examination of Levee Vegetation Policy," held in February 2009 in Renton, Washington.
- The Corps allow the current Seattle District regional variance to remain in place until collaborative research regarding the effects of vegetation on levees in the Pacific Northwest can be completed.
- The Corps consider local conditions and opportunities in its vegetation management policies.
